Presidents' Message

The review of Gravenhurst's Official Plan continued in 2016. The KLRA lake plan remains with no changes. The Official Plan has been accepted by the District of Muskoka with the appeal period in effect until June 14th 2017.

The Rock Marker Committee, led by Barry Elder, along with Troy Hutchinson continued to work hard to have the rock marker system in place for the May holiday weekend and removed after Thanksgiving weekend in 2016. Troy Hutchinson agreed to help with the 2017 spring set up of the flashing rock markers. Your continued financial support for the Rock Markers is very much appreciated.

Ron Pearson, your lake steward, continued his leadership of the water quality monitoring and assessment. His extensive report for Kahshe and Bass Lake is included within this report. Ron has outlined again in this year's Report, how we can maintain the eco system in Kahshe and Bass lakes.

Ice-Out Contest

Conservation Committee Report

Town of Gravenhurst Official Plan Update

In the summer of 2015, the Town of Gravenhurst began a process to update their Official Plan. It is a process that is required by Ontario legislation. The last Official Plan for Gravenhurst was passed by Council in June 2008.

The process was managed by Planscape Inc, consultants in Land Use Planning and was completed in December 2016, when Council passed the revised Official Plan. The process involved several public meetings to provide updates and solicit input, as well as an on-line survey. KLRA actively participated, by submitting position papers, commenting on proposed changes, requesting members to review the updated mapping information and complete the survey. At least one person from KLRA attended every public meeting.

Revisions were required to align with both Provincial and District changes which have happened since June 2008. More accurate mapping data has been developed since June 2008 and was incorporated. The Town's new (in 2015) Strategic Plan was another key input.

Here is the summary from KLRA's initial written submission in October 2015.

"In summary, the current Town of Gravenhurst Official Plan and its enabling By-Laws appear to be working well for Kahshe and Bass lakes. As such, we see no need to make modifications.

We are interested in:

- Strengthening policies which support guaranteed long term access for water access properties.
- Engaging our membership in the review exercise.
- Your thoughts on a communication plan which includes seasonal residents.

• Participating in the review if you think our association can help

We look forward to reviewing the 'issue papers' when they are completed."

As a result of input from many groups and members of the public, drafts of the updated Official Plan were circulated and shared at Public meetings. KLRA submitted a final letter, summarized below.

"Overall, we are supportive of the draft as written.

Specially, we support the proposals on:

- Boat Houses, i.e. one storey on Kahshe, limited by lot width, subject to the side lot set back and focused on marine equipment,
- Sleeping Cabins, which recognize a 2nd cabin on larger lots and includes accommodations above a detached garage,
- Roads, recognizing that some private road expansion is appropriate and can mitigate challenges associated with water only access properties,
- Renewable Energy, however, we are concerned that sufficient science is not be available to allow extensive use of lake loop systems

As you know we are very concerned about access to docking and services (septic clean-out etc) for our 'water access only' members. While we recognize the challenge associated with 'legally securing' access to landing and services, we want to emphasise the importance of this section to the KLRA membership. Kahshe Lake has one of the largest number of 'water access only' properties, in Gravenhurst. There are many 'mainland' cottages to which roads cannot be built, due to Conservation Lands, and many islands to which roads are not feasible. It is important to KLRA for the Official Plan and subsequent By-Laws to recognize the requirement of these properties to have access to basic services.

After hearing the delegations on August 23rd, we support the position to maintain existing wording concerning Lake Capacity until such time as the District's new model is finalized and approved."

While KLRA still has concerns, which we feel have not adequately been addressed, on balance, we are pleased with the process and outcome.

The next phase for the Town will be to translate the new Official Plan into revised By-Laws. KLRA will be an active participant in this process as we were in 2010 during the last update.

2016 Kahshe and Bass Lake Steward Report

A comprehensive review and analysis of all historical environmental monitoring on Kahshe and Bass Lakes has now been completed and presented in annual Lake Steward Reports from 2012 through 2015. These documents are posted on the KLRA web-site (kahshelake.ca/ne/ls). This Executive Summary report captures the findings from sampling and analysis of both Kahshe and Bass Lakes in 2016. The sampling programs include those of two agencies: The District Municipality of Muskoka (DMM) and the Ontario Ministry of Environment and Climate Change (MO-ECC). In the latter, the Lake Stewards of Ontario carry out the sampling and measurement and the MOECC analyzes the samples and coordinates the data reporting. As in 2015, the full report has been structured to address the following issues/areas of potential concern for both lakes:

Total Phosphorus and Water Clarity

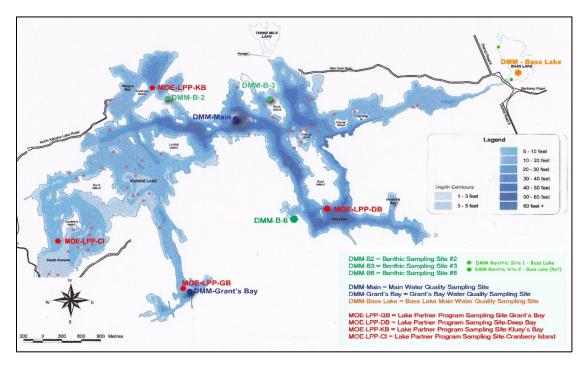
- Calcium Depletion
- Lake Acidification
- Dissolved Oxygen and Water Temperature
- Metals and Other Chemicals
- Benthic Health

Weather and Water/Ice Conditions in 2016

In order to better understand the chemical and physical data that have been collected, this year's report includes an overview of the climatological factors that have the potential to influence the analytical findings. This attempts to answer the question: How normal were temperature, rainfall, water levels and ice-out conditions compared to past years?

The information on weather and water/ice conditions confirmed that 2016 was warmer and dryer during the summer months, with fairly normal water levels throughout the year. However, consistent with the 125 year trend of earlier ice-out dates for Muskoka Lakes, ice-out on Kahshe Lake was earlier than normal in 2016.

The map below shows the locations of all sampling sites for both DMM and MOECC sampling programs, while the summary table that follows provides brief information on each of the six key issues. The two new benthic monitoring sites which were added to Bass Lake in 2016 also are shown.

In conclusion, based on the foregoing summary of the environmental monitoring of Kahshe and Bass Lakes, no major issues in terms of environmental quality have been detected.

Although there are no detectable environmental issues, we need to continue with our sampling efforts and practice overall lake stewardship to delay the onset of nutrient enrichment and its impact on lake health.

How can we make a difference? Each of us can do our part to maintain the quality of the water by:

- managing our septic systems properly and having tanks pumped out regularly based on use;
- avoiding the use of products containing phosphorus (detergents and cleaners);
- disposing of toxic wastes (batteries, paint, oil, old gas, pressure-treated lumber and other construction waste) at approved land fill sites;
- minimizing near-shore removal or management of vegetation and ensuring that any shoreline disturbance is conducted in compliance with permitted uses:
- avoiding the use of any chemical fertilizers or pesticides in areas close to the shore; and,
- taking precautions to minimize the introduction of both terrestrial and aquatic invasive species.

Nagaya Beach

Due to the weather and number of young families in the area, our Beach was very well utilized this summer. In general our members and users were very respectively of the beach and the facilities.

We did have a slow start getting the swim floats and port-a-potty. Many families help with early year clean and tidy up.

We had problems with the Floating docks (Big and Small) being "released and set free", several times early in the year. We decided to leave the big dock in place of the winter (with Safety Reflectors in place). This resulted in less wear and tear on the platform and better security for our equipment. We will be following this procedure going forward.

Scott Dunlop was engaged for the beach maintenance and will be again for the 2017 year.

We want to remind everyone that the Beach is not a safe place to bring motorized boat or SeaDoos. We hope everyone can help re-enforce common sense best practice for members and non-members.

Give the potential of changing our membership structure we feel that campaigning the users of the Beach would be a good target for additional revenue.

Water Access Committee Report

Happy Cottage Season 2017!

The opening of the summer cottage is a lot of work for every cottager, and especially so for water access cottagers. Marinas need to have their docks in, boats have to be in, the ice has to be out and there has to be somewhere to dock a boat at the cottage when arriving. The fun doesn't stop. This winter seemed to be more damaging than others with the huge amount of snow, later than normal ice melting and ice movement through the winter. Many cottagers saw their docks collapse, go missing or get broken up and no one enjoys that sight when arriving at the cottage for the first time to start the season.

The town of Gravenhurst rebuilt the government dock at Rockhaven, which looks fantastic. We shall see over the next few months whether its height proves to be difficult for loading and unloading of boats. The need of a floating section as we had before may be something to consider. But regardless, thank you, City Hall!

We are also still hoping for new street lights at the government docks.

I participated in a Electrical Safety Association conference recently and lo and behold they handed out a pamphlet regarding the Electrical Safety Around the Dock. Here is a summary of the highlights:

- Dock owners are responsible for ensuring that the electrical installation and equipment around docks and boathouses are maintained and in safe working order.
- Electricity leaking into the water surrounding a dock or boat is caused by a malfunction of electrical equipment or faulty electrical installation.
- If someone enters that area of water, they could lose muscle control, not be able to swim to safety or call for help.
- At least one person dies in North America every year from electrical shock drowning.
- Dock owners need to ensure that GFCI (Ground Fault Circuit Interrupter) breakers are used for receptacle or lighting circuits on and around docks and boathouses. This includes circuits with submersible water pumps. If something happens the owner is responsible.
- Make sure that all frayed and exposed conductors are repaired immediately and use three prongs (a ground conductor) on all conductors.

As usual, make sure that your boat(s) have all of the safety gear aboard for the safety of people on board and to keep away from those pesky, expensive fines.

Safety and marina dock quality is always a concern. If you notice missing, or rotting boards on the docks that you pay to rent every year, please make the marina owner aware of it. It is in everyone's best interest that docks are maintained to avoid accidents or mishaps.

Happy 2017 and cottage safely.

Town Liaison

This function of the KLRA Board of Directors deals with the Town of Gravenhurst and the District of Muskoka on municipal planning and by-law enforcement issues.

During 2016, four applications for zoning amendments, two severance applications, and two variance applications for properties around Kahshe and Bass Lakes were reviewed at the request of the Town. We offered no objections to most of the proposals, and requested clarification on some of them.

The Conservation Committee worked with the Town of Gravenhurst during the year on revisions to the Town's Official Plan. This is covered in detail in the Conservation Committee section.

Communications, Outreach & Membership Committee (COM Com.) Report

2016 was another busy and successful year for the Communication, Outreach and Membership Committee (COM Com). In this our fourth year, we feel that much was accomplished. Eight very active volunteers make up our committee. They represent all parts of the lake and bring a richness of experience, ideas and enthusiasm. Interestingly, many of our members also have additional roles within KLRA. Our group has a wonderful "esprit de corps" and draw energy from each other

Over the year, we held 6 formal meetings as well as numerous virtual meetings and countless emails.

COM Com. researched and subsequently purchased new canopies for KLRA. We were able to secure a very good deal. As a result, we bought two 10'x10' pop-up canopies and one 8'x8' canopy. The larger ones are needed for major events, such as the Craft Show, where they will be used for the photo contest. The smaller one can fit on the floating dock and be used by the organizers of the fishing Derby. Naturally, these canopies will be used at many different KLRA events.

The **Boutique** has proven to be a focus of activity during many lake events. We designed and sold a variety of products. These included t-shirts for ladies, men and children in assorted colours. We also sold coffee mugs, baseball hats and children's sweatshirts. These clothing items were all produced locally, in our endeavour to support our local businesses. Last year we introduced the popular glass steins; used for whatever beverage people wanted to put in them. We continue to sell the KLRA flags; ones that features the KLRA logo and can be flown on boats or put up on the wall of a cottage or home. The boutique was also the place where people could purchase copies of our lake history, 'Healing Waters'. Patrons of the boutique also appreciated the ability to pay their membership dues on the spot.

We set up shop at 5 different events during the summer and we are delighted with response and outstanding sales that resulted. A very well received feature of the boutique was that all KLRA members received instant discounts.

The boutique was a source of many prizes for contests and occasions around the lake this year. These were well received and heightened the excitement at these events.

In the fall, we ran the Virtual Boutique again. It provided opportunities for people to place orders on-line. Offerings included the calendar, pennants and copies of both volumes of our lake history. Our customers told us that they liked being able to place orders and have them shipped as gifts.

The **Kahshe Krier** is a highly-anticipated newsletter that is on many peoples must-read list. It is published three times a year. The editor was instrumental in coordinating our annual Dock and Door Drop, a highly successful outreach that saturated our community. The cost of this newsletter is partly underwritten by the generosity of our advertisers. In order to keep costs under control, it was decided to add a surcharge to any member who requests that the newsletter be printed and mailed to their home.

Our website continues to be a dynamic source of information and forum for our members. It is rich with information and increases on a regular basis. Many people use it as a reference point as well as a gateway to contacting members of the Board.

The **Photography Contest** continues to generate much interest. It is a highly-anticipated event featuring the creative work of people at the lake. A panel of expert judges decided upon the winners for each category and age group. The winners received plaques that featured their photos as well as a gift voucher for the boutique. Our website proudly displays the entries and the winners. It is also a good source of information and tips for photographers.

Our committee created another **Kahshe Calendar**, using the excellent photos from the Photo Contest. This was so well received that we produced a 2017 version and sold it during 2016. This way, people could purchase calendars all year, give them as gifts to be enjoyed the following year.

The **community bulletin boards** are strategically positioned around the lake. In 2016, we refurbished them, replacing the cork backing and repairing some of the wooden supports.

The **KLRA motto** was modified this year and approved at the AGM, to be more inclusive and welcoming. It now reads "*KLRA – dedicated to the preservation of the environment for future generations."* Our committee then ensured that stationery, banners and other outreach materials featured the new motto.

Recognition and awards is a vital part of a dynamic association. Our fourth year of the **Outstanding Volunteer Award** was equally successful. Alex Milburn, a long-standing volunteer, received the award at the AGM and proved to be a very popular choice. His award was an engraved canoe paddle and certificate. (You can read more about this award and about Alex on our website).

A major development in 2016 was our venture into **Facebook and Twitter**. Our committee welcomed a new member who had vast experience in social media and is running this outreach. We have active communities following both. This has allowed us to reach individuals who want immediate contact on their computers, tablets and phones. Our Facebook page is linked to the other Kahshe Lake Facebook pages and there is good sharing and linking amongst them. Twitter messages are also shared amongst users.

All in all, 2016 was another fine year for our committee and we eagerly look forward to the activities for the next year.
