- 4). Through the **Conservation Committee**, the Love your Lake Program, sponsored by the Canadian Wildlife Federation and Watersheds Canada was completed in 2019. Every property owner on the Kahshe and Bass Lakes should have received a report in early 2020.
- 5). Our financials are stable and our membership fees remain unchanged at \$40.00 for a one year membership and \$99.00 for a three year membership. We can work comfortably for 2020.
- 6). Waste Management. The Province of Ontario in June 2019 notified the District of Muskoka that certain garbage bins were illegal and had to be removed. Unfortunately three sites on Kahshe Lake were identified, the Kluey's Bay site (Rockhaven), Denne's Marina and Nagaya Beach as high priority sites. The KLRA worked diligently on this issue by developing and sending waste management questionnaires to all KLRA members. Bob Reyburn and I attended meetings with the District Engineering and Public Works department. We continue our involvement, but to date no decision has been made, regarding future waste management for the bin sites. An additional waste management survey for boat access cottagers only will be sent out shortly.
- 7). The Lake Steward Report continues to highlight the healthy state of Bass and Kahshe Lake. We are so pleased that cottagers continue to be aware of how their activities can impact the health of the lakes.

Bass and Kahshe Lakes are special places where families come together, where life experiences happen and memories are shared that last a lifetime.

Lake Stewards Report

SUMMARY OF 2019 WATER QUALITY FINDINGS

JULY 2020

As recreational property owners and general public users of our beautiful lakes, we share a concern regarding the quality of the water now and for the future. This concern was clearly identified in a recent Love Your Lake questionnaire which was undertaken in 2019 with the support of the KLRA. Water quality was the single most important issue identified for both Lakes. However, as several respondents indicated that they were not aware of work undertaken to monitor water quality, it was apparent that we needed to improve the communication of the environmental findings. Accordingly, the KLRA web-site has been re-designed to make this work more transparent and accessible through the creation of a new portal on the Home Page, titled **Lake Health**. A brief summary of the 2019 water quality findings for Kahshe and Bass Lakes follows.

Kahshe Lake is being monitored for water quality under two main initiatives as outlined below. Because of its smaller size, the water quality program for Bass Lake is limited to the more comprehensive Lake System Health Program.

Lake System Health Program

This program is operated by The District Municipality of Muskoka (DMM), with support from the Muskoka Watershed Council (MWC), the MOECP and several other participating agencies. For Kahshe and Bass Lakes, the DMM program consists of the following activities which are conducted every other year for Kahshe and lately, every year for Bass Lake:

- Spring phosphorus sampling conducted in May.
- Water sample collection for over 30 other chemical parameters in May.
- Secchi depth measurements collected in May and August.
- Temperature and dissolved oxygen readings collected from increasing water depths from the surface to the bottom of each lake in May and August. and;
- Benthic monitoring of Kahshe and Bass Lakes was conducted at established reference sites in both lakes from 2012 through 2018.

Lake Partner Program

This program is operated by the Ontario Ministry of Environment, Conservation and Parks (MOECP) through the Dorset Environmental Science Centre (DESC). Under this program, water sampling and measurement of water clarity is conducted by the Kahshe Lake Steward every year.

The program consists of the following activities:


- Water clarity measurements
 - Clarity of the water is measured every two weeks during the ice-free period at three locations using a Secchi disc, and these findings are forwarded to the MOECP for compilation and comparison with other lakes in Ontario.
- Water quality testing
 - Water is sampled from the same three locations in May each year and sent to the MOECP
 where it is analyzed for total phosphorous, an indicator of the potential for algal blooms and nutrient enrichment and for calcium.

SUMMARY OF WATER QUALITY FINDINGS

A detailed report on the findings of this water quality sampling for both lakes has been provided in the Lake Steward reports from 2012 through 2019 and in related Executive Summaries. This report will summarize the finding.

Total Phosphorus

- Because of its importance in the growth and development of algal blooms, total spring phosphorus is measured by both programs.
- Kahshe Lake is currently at a level just below pre-established background concentrations and has shown no evidence of an increase or decrease over the 35+ years it has been analyzed.
- Total phosphorus concentrations in Bass Lake are about 2-3 times higher than in Kahshe Lake, but have not increased or decreased over the 35+ years; however, because Bass Lake levels exceeded 20 μg/L, the lake was flagged as a 'Transitional Lake' by DMM and has been sampled every year since 2016.
- Both lakes have been determined by DMM to be low in terms of responsiveness to phosphorus in-



put. However, because of limited soil attenuation potential, the phosphorus mobility rating is high. The combination of these two factors results in a moderate sensitivity classification, meaning we need to stay vigilant in maintaining it at or below these levels.

• Another important factor which could influence the relationship between total phosphorus and algal blooms is lake temperature. DMM water temperature readings for the

upper layers of both lakes appear to confirm the findings of others that have shown gradual warming of the upper layers of Muskoka lakes, and this has the potential to accelerate algal growth in combination with total phosphorus and nitrogen.

In the 2019 Lake Steward report, it has been noted that several lakes in the Muskoka area have experienced harmful blue-green algal blooms in 2018 and 2019. To give some perspective on the likelihood of this happening in Kahshe or Bass Lakes, the total phosphorus levels in lakes experiencing harmful algal blooms were examined and compared to those of our lakes. A chart of the findings has been inserted below.

This analysis has revealed that harmful blue-green algal blooms have developed in several lakes that had total phosphorus levels well below those in Kahshe and especially Bass Lakes. Based on these findings, it is even more important to keep our nutrient loading to a minimum, as warming waters associated with climate change are likely responsible for these algal blooms.

Secchi Depth (Water Clarity)

- The clarity of water is affected by the amount of dissolved organic carbon (tea colouring) and also by increasing levels of nutrients such as phosphorus and nitrogen, which are known to stimulate algal growth.
- Kahshe Lake is rated as 'moderate' in terms of its dissolved organic carbon concentrations; however, based on the DMM and MOECP measurements over the years, the clarity level is slightly less than the 3-5 m typical depth for a Mesotrophic lake (a lake with moderate levels of nutrients and plant growth) and more representative of clarity in a mildly Eutrophic lake (a nutrient-rich lake).

Dissolved Oxygen and Water Temperature

- DMM's evaluation of these two parameters has been ongoing for several years, and is important as both can have impacts on the health of aquatic receptors and, in the case of water temperature, on the potential for algal blooms.
- Based on the findings to date, the dissolved oxygen levels appear to be well within the normal and healthy range for most aquatic organisms and although some changes have been noted, they do not appear significant in terms of aquatic health.

Calcium and Acidity

- As calcium concentrations in Muskoka lakes has been decreasing because of improved pollution control on sulphur and other chemicals, there is concern that this could result in undesirable changes to water borne zooplankton species that require it and which are important in the aquatic food web.
- To date, the levels in both lakes are above the threshold for aquatic impacts, so this is a positive finding.
- Water acidity also is monitored and in both lakes, is well within the expected range.

Other Chemicals

- To evaluate the significance of the analytical results for a large suite of chemical parameters which have been analyzed for but not reported on by DMM, the data were assessed against surface water quality benchmarks set by the MOECP and other agencies to protect aquatic receptors (fish and other life forms found in fresh water) against impacts over long-term exposure periods.
- This analysis has confirmed that for all but two chemicals, the concentrations of these parameters are well below established aquatic benchmarks.
- For cadmium and copper, the analytical detection limits exceed established aquatic benchmarks. However, as the reported exceedances are assumed to be at the lab's detection level, this is not considered to be of concern.

CONCLUSIONS FROM WATER QUALITY SAMPLING

Based on the analysis of a large number of chemical and physical parameters by both the DMM and the MOECP, it is apparent the waters of Kahshe and Bass Lakes are in reasonably good condition and compare favourably with the results for other Muskoka lakes. However, given the initial signs of increasing water temperatures which are consistent with the findings from other lakes in Muskoka, we need to remain vigilant in our sampling efforts and overall lake stewardship, as warmer waters are more prone to algal growth and may negate potential improvements in nutrient enrichment and other chemical indicators of lake health. We can improve water quality and reduce the potential for algal blooms via these three actions:

- Pumping out and having our septic systems (tanks/leaching beds) inspected on a regular basis:
- Managing our shorelines to keep them as natural and as vegetated as possible to minimize soil erosion directly into the lake, and;
- Completely avoiding the use of phosphorus or nitrogen fertilizers on any existing lawns, gardens or flower beds in the vicinity of the shoreline.

Rock Marker Report - July 2020

During the 2019 cottage season, the Rock Marker Committee maintained and installed all white spherical ball rock markers and several column buoys with flashing lights. Some column buoys however, had to be substituted with white spherical balls due to requiring replacement lights. Lights were obtained late in the season and were added to the column buoys ready for the 2020 season. After Thanksgiving weekend 2019, all spherical buoys and column buoys with lights (except one that has an extremely heavy concrete weight attached) were removed for the winter season.

Due to unprecedented times, the Rock Marker Committee had a slow start placing all of the KLRA rock markers in the lake this season. As mentioned above, these rock markers consist of 18-inch round buoys (white balls) and column buoys that are 10 inches in diameter, stand 39 inches above the water and have an amber light affixed to the top that flashes on for 1 second, then off for 3 seconds.

Each spring, these markers must be placed in the lake and then removed and stored for the winter season. In the case of the column buoys, the lights must be removed and properly stored so that the batteries do not freeze over the season.

We do have a crane that can be affixed to the front of a pontoon boat to assist with managing the heavier column buoys, but it is still work that needs strong, able-bodied volunteers to assist.

Come this fall <u>we do not have</u> the volunteers we need to remove the rock markers. This is typically done after/on the Thanksgiving weekend. Therefore, we need volunteers. Any help that you can provide is greatly appreciated. You do not need to remove all of the markers, but perhaps just those close to your cottage. If you can help with the lighted column buoys, terrific. We can use the crane to assist with lifting. I will coordinate this work, and provide all the information needed. So if you are interested in volunteering a few hours of time, please send me an email at KLrockmarkers@gmail.com.

Moving forward, the committee is building more permanent lighthouse towers with amber lights that flash, using the same/similar design as the ones currently on the lake. These permanent lighthouse towers will be affixed to land/rock and will not need to be installed and removed each season. Before Covid-19, these towers would have been ready to install this summer. Now we are hoping that they can be built and installed by the end of the 2020 cottage season.

Installation of these permanent lighthouse towers are planned for the following locations:

- 1. East end of Hens & Chicks (on the most easterly rock that is above water)
- 2. West end of Hens & Chicks (on the most westerly rock that is above water)
- 3. Most easterly rock before Bass Lake Entry (installed on cement tower currently there)
- 4. At the west entrance to Grant's Bay where the channel coming out of the kettles meets the west channel of Grants Bay
- 5. East of Chief Island
- 6. South end looking for a suitable location would appreciate input from residents

Please let me know if you think a permanent lighthouse tower should be installed at another location on Kahshe Lake. As is the aim with all of the KLRA rock markers, the permanent lighthouse towers should assist boaters with navigation through the main channels of our lake.

We also introduced a new model of lady's t-shirts and these

The boutique continued to be a place where people could purchase copies of our lake history, "Healing Waters". Patrons of the boutique appreciated the ability to pay their membership dues on the spot. Well done Boutique Staff!

The boutique was a source of many prizes for contests and occasions around the lake this year. These were well received and heightened the excitement at these events. We are pleased to report that the boutique set new sales records this year. Please note that all the profits from the boutique are used to support the work of KLRA. All parts of the boutique are run by volunteers.

In the Fall, we ran the **Virtual Boutique** again. It provided opportunities for people to place orders online. Items selected for the Virtual Boutique had to be easy to ship. Our treasurer did an amazing job tracking the orders and updating the available stock on line. Our customers told us that they liked the convenience of being able to place orders and have them shipped as gifts.

The highly-anticipated newsletter, **Kahshe Krier**, is published three times a year. The cost of this newsletter is partly underwritten by the generosity of our advertisers. Well done to our editor!! He was instrumental in coordinating our annual Dock and Door Drop, a highly successful outreach that saturated our community with valuable information about the lake and about KLRA.

Our **KLRA** website continues to be a reference point for all things Kahshe Lake. Our webmaster works tirelessly to keep it current. A new feature is the dynamic slide show that features photo contest entries from previous years. The website is always undergoing changes in order to be more efficient and relevant. The website also serves as a gateway to contacting members of the Board.

The **Photography Contest** is always an activity that generates much interest. It is a highly-anticipated event featuring the creative work of people at the lake. One hundred twenty-seven entries were submitted. A panel of expert judges decided upon the winners for each category and age group. The winners received gift vouchers for the boutique and had their photos displayed on our website. Be sure to check out the website since it is a good source of information and tips for photographers.

The **community bulletin boards** are strategically positioned around the lake. Volunteers continue to monitor them and put up KLRA information.

Recognition and awards are a vital part of a dynamic association. Our sixth year of the **Outstanding Volunteer Award** was equally successful. Lauren Koenig, a very creative and hardworking volunteer was recognized for her entrepreneurial spirit and fund raising to support our rock markers. Her award was an engraved canoe paddle and certificate.

Both our **Facebook and Twitter** accounts continue to grow and we have active communities following both. This has allowed us to reach individuals who want immediate contact on their computers, tablets and phones. Over the July-August period, we reached over 1100 people. Our Facebook page is linked to the other Kahshe Lake Facebook pages and there is good sharing and linking amongst them. Twitter messages are also shared amongst users.

COMCom committee members **volunteered** many hours for our association. We also had the support of approximately another dozen volunteers, who support the work of KLRA. We sincerely thank each and every one of them for their generous donation of time and talent. This is another thing that makes KLRA great!!
