9. Open discussion

(a) Nagaya Beach

Issues identified at the beach this year, including people cooking on the beach, leaving garbage, not using washroom facilities, dogs on the beach, illegal parking, etc.

Stephanie Boyd asks the KLRA acknowledge the issues, need to be some education around what is going on at the beach. Bathrooms are a problem, and the second is parking, there are 11 rules on the beach sign, and on weekends 8 of them are regularly broken. Would like to make this a residents only beach.

Action: Strike a committee made up with two people from the beach, two board, members, two people who aren't from the beach or board members to come up with a plan to be presented in the spring.

(b) Large Wake Hazards – Presented by Henry Kowalski Issues such as damage from boats creating large wakes to shore lines, docks, boats, etc.

Lack of education for some of the owners of wake boats re emptying their chambers when not wakeboarding, knowing where to go to wakeboard so you are not in a narrow channel, etc. Boat owners and drivers are not educated to the fact that large, damaging wake is against the law.

Needs to be more education to owners/drivers of these boats about the chambers. Make sure people understand it is against the law. Engage town about possible Wake Height Maximum, take a picture or video of a boat you feel is damaging the shoreline or your docks/boats to have a record of the incident/s.

Action: Henry and others to work on some educational material, etc. Have some signage posted re speed limits, etc. See about getting more enforcement. Connect with other lake associations to see what they are doing, work together to try and affect change.
